## WM Library Bus Permission Form

Dear Parents and Guardians,

Beginning on Monday, November 6, 2017, the West Milford Township Public Schools will provide an after-school bus route directly to the West Milford Township Library located at 1470 Union Valley Road in West Milford for all students age 12 and up. This program does not designate or specify certain days for use of district busing for this purpose. Rather, by signing below, you are providing “blanket” permission for your child to participate at their discretion. If your child elects not to ride the library bus on any particular day, the student’s current transportation protocols remain in effect as they would on any regular school day and you remain responsible for arranging pickup for your child from the school building or the student’s bus stop, as may be necessary.

**The West Milford Schools will consider the WM Library to be an end of route portal, or bus stop. The signing, acceptance, and return of this permission slip acknowledges that the schools take no responsibility for student transportation after they have been delivered to the Library and have entered the building.** Students bused to WMTL will be responsible for their own activities and usage of the Library, with all the privileges and obligations any Library user is afforded by WMTL’s guidelines, standards, and policies. **One such policy states, “Students must be 12 or older to use the Library without a guardian on premises.”**

- No child under the age of 12 may participate in this program.
- Parent or guardian must agree to provide or arrange transportation from the WMTL before library closing hours. Library hours available at <http://www.wmtl.org/>
- Students receiving parent permission to participate must adhere to the WMTL policies and guidelines.
- Students are expected to adhere to the West Milford Township Public School’s Code of Conduct, HIB, and Acceptable Use Policies as part of this program.
- Students in violation of the above stated information will be removed from this program and will no longer have access to district busing for this purpose. Furthermore, library and district personnel will communicate in regard to student adherence to these policies.
- District administration reserves the right to deny student participation in this program at any time.
