# BOARD OF EDUCATION MINUTES SPECIAL MEETING THURSDAY, MARCH 28, 2024

Mrs. Claire Lockwood, Board President, called to order the Special Meeting of the Board of Education at 7:00 p.m., in the Macopin School Cafeteria. She asked for a moment of silence, led the flag salute, read the Open Public Meetings Act Statement, and reminded everyone in attendance to silence or turn off their cell phones, and note the locations of the emergency exits.

## VI. PURPOSE OF MEETING

The purpose of the meeting is to appoint a Superintendent of Schools, effective July 1, 2024.

Mrs. Lockwood addressed the community with a statement:

"First off, we would like to apologize to the community for the delay in releasing the Agenda. We had the intention of doing a full transparent release of who the candidate is once we received final approval from the County. This took a little longer than we expected. We received the approval today. A lot of time and effort went into the task of finding our next Superintendent. We would like to thank Mrs. Kathleen Helewa, Educational Consultants, for all that you did to get us to this point. Your expertise and professionalism were evident throughout this process. I would also like to thank Mr. Scholts and my fellow Board members who were part of the Superintendent's Search Committee, for all of the days, nights, and months that you committed to this very important process. Finally, thank you to our community for your feedback and completion of the input surveys. They gave us important data to draft a strong candidate profile to try and guide us in finding the best candidate for the District. Because of the large number of applications we received, twenty-nine (29) in total, we were able to narrow the pool to nine (9) very strong candidates, all of whom showed exemplary qualities. Dr. Brian Kitchin, throughout the three (3) interviews, stood out and impressed all of the Board members with his student focus, his achievements in building teacher and administrator capacity, his financial acuity, his commitment to the community, and his ability to build strong relationships. He comes to us with almost sixteen (16) years of experience, almost ten (10) years as a Health and Physical Education teacher in a regional school district, four (4) years as a Middle School Principal, and the past two (2) years as a Superintendent. His doctoral dissertation was a correlational study between self-esteem and academic achievement. We are delighted to have on our Agenda for approval tonight a dynamic, innovative, and visionary leader."

## VII. PUBLIC COMMENT REGULATIONS

- 2. Each speaker shall be limited to five minutes. The Board Secretary will note the time. A speaker who has not finished in the allotted time will be directed by the presiding officer to summarize quickly and relinquish the floor within 30 seconds (Bylaw 0167).
- 3. Comments shall be limited to issues. If personal remarks or discourteous statements are made, the presiding officer shall require the speaker to stop.
- 4. All statements shall be directed to the presiding officer. No participant may address or question Board members individually.
- 5. Questions requiring investigation shall be referred by the Board to the Superintendent's Office for consideration and later response. A participant may be asked to submit such questions in written format.

Mrs. Lockwood congratulated Dr. Kitchin as the new Superintendent of Schools.

Dr. Kitchin addressed the Board and the community. He thanked Mrs. Lockwood for sharing some of his educational background with the community. He also wanted to share with the community who he is as a leader. He spoke about his relationship with the Board and looks forward to working with all of the Board members. He thinks it is very important that their relationship is collaborative, which begins with communication from his side to make sure that the Board understands what is going on in the District because he is the bridge between the Board and the schools. He spoke about the leader he is with Administration and staff, and feels it is important that he recognizes that his role is not to step in and know everything, but his job is to recognize the collective strengths of the community and of the staff as a whole. He recognizes that the staff in this District has centuries of collective experience, and feels that tapping into that is really important for the success of the District. He also recognizes that we can help each other learn and grow in challenges that may arise. As a leader in the community, he thinks it is really important that people recognize that we are partners with the community, the families, and the District in raising these young men and women, and making them productive members of society. He expressed that not a single person in this community cares more about the success of our schools than our parents. He feels it is our job to give parents comfort in the trust that they give us in educating their children by showing them all of the wonderful things we are doing and demonstrating success in educating their children. Lastly, his view on the students of this District which is the reason we are all here. The students are the most important part of a District and he stated one of his favorite quotes, "prepare the child for the path, not the path for the child," and feels this really holds true in Education. He feels that if we arm students with the tools to take challenges on, then they can meet any challenge with success, including reading, writing, math, science, social interaction and problem solving, which is all part of the education that West Milford should be striving to put forward for our students. It is our job as a Board, as staff, and as administration to make sure we are carrying that out and keeping the focus on students. He is very excited to start working in this District, and he genuinely appreciates that the Board has faith in him to be the District's new next school leader.

She is very excited about the new chapter for West Milford and she is looking forward to working with him. She expressed that his philosophy of the relationships between all of the stakeholders excites her to know that we will be moving forward with someone who truly cares about the education of our students.
